

**Excerpt from PO Christopher Quirk's CCRB Interview, ~9:00-10:43**

INVESTIGATOR LIROFF: I see that "the deponent states that the deponent observed the defendant standing over Sergeant Timothy Horohoe, shield number 904170, 14<sup>th</sup> Precinct, taking pictures of Sergeant Timothy Horohoe effecting lawful arrests of two separately charged individuals, Deponent further states that the Sergeant Timothy Horohoe told the Defendant that the Defendant was allowed to take pictures as long as Defendant backed away from Sergeant Timothy Horohoe while Sergeant Timothy Horohoe was effecting the said lawful arrests." Um, now, are these things that you actually observed or this was information that Horohoe gave you?

OFFICER CHRISTOPHER QUIRK: This was- this is information that Horohoe, he said that uh, read that again?

INVESTIGATOR LIROFF: [inaudible], "the deponent states that the deponent observed the defendant standing over Sergeant Timothy Horohoe, shield number 904170, 14<sup>th</sup> Precinct, taking pictures of Sergeant Timothy Horohoe effecting lawful arrests of two separately charged individuals, Deponent further states that the Sergeant Timothy Horohoe told the Defendant that the Defendant was allowed to take pictures as long as Defendant backed away from Sergeant Timothy Horohoe while Sergeant Timothy Horohoe was effecting said lawful arrests."

OFFICER CHRISTOPHER QUIRK: Yes, that's, I, Sergeant Horohoe told me, he told them to get back. I saw him with Jordan Groh, Sergeant Horohoe told me to tell them.

INVESTIGATOR LIROFF: OK, but the information here, the information Sergeant Horohoe gave you about-

OFFICER CHRISTOPHER QUIRK: Yes.

INVESTIGATOR LIROFF: - Mr. Groh's actions.

OFFICER CHRISTOPHER QUIRK: Yes.

INVESTIGATOR LIROFF: OK, and this deposition, did you prepare this at the district attorney's office, or did you do it at the station house?

OFFICER CHRISTOPHER QUIRK: This was at- they faxed, faxed it to me.

INVESTIGATOR LIROFF: OK, so, um, you actually, you typed this up?

OFFICER CHRISTOPHER QUIRK: No no, the DA typed that up, and then it was given back to me.

INVESTIGATOR LIROFF: OK, so you uh-

OFFICER CHRISTOPHER QUIRK: I talked to the DA over the phone-

INVESTIGATOR LIROFF: You talked to the DA over the phone, you said this is what happened-

OFFICER CHRISTOPHER QUIRK: Yeah, you call it, "D-CAP," it's called

INVESTIGATOR LIROFF: OK

OFFICER CHRISTOPHER QUIRK: They talked to me over the phone, I told them my part of the story, they write up, and [inaudible], you know?

INVESTIGATOR LIROFF: Um, so again, that information about Groh's conduct was information that was given to you by Sergeant Horohoe?

OFFICER CHRISTOPHER QUIRK: Sergeant Horohoe, correct.

INVESTIGATOR LIROFF: and then, by the time you turned around, he was already being placed under arrest?

OFFICER CHRISTOPHER QUIRK: That, um, by the time I turn around, I saw the crowd surrounding him, Sergeant Horohoe, I believe, you know, told Jordan at that time that he was placed under arrest, but I can't recall 100% what happened.

INVESTIGATOR LIROFF: OK.

**Excerpt from Sgt. Timothy Horohoe's 11/1/07 CCRB Interview, ~25:25-25:40**

SERGEANT TIMOTHY HOROHOE: ...from his observations. I don't instruct anyone how to testify.

INVESTIGATOR LIROFF: OK, did you give him any information regarding the arrest, or what language to use with these individuals?

SERGEANT TIMOTHY HOROHOE: Again, I don't instruct anybody how to testify. His observations are the basis of his testimony.
